- All Federal Motor Carrier violations of R17-5-202-\_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_. All are Class 2 Misdemeanors. Maximum penalty, \$750 fine, up to 4 months in jail. The fine for **EACH** count is **\$320.00**. NOTE: Any citation for possession or use of any drug or paraphernalia requires a court appearance. **R17-5-202-392.16, NO SEAT BELT, \$92.00.**
- A.R.S.28-3473C - Driving on Suspended Driver's License. Class 1 Misdemeanor. Maximum penalty, \$2500 fine, up to 6 months in jail. The **mandatory fine is \$600.00**, and \$968.00 for a second offense. The fine can be lowered to **\$140.00** if Defendant provides proof to this court that all obligations to other courts have been satisfied.
- A.R.S.28-3473A - Driving on Suspended Driver's License. Class 1 Misdemeanor. Maximum penalty, \$2500 fine, up to 6 months in jail. Mandatory minimum base fine \$300 plus surcharges and court fees. The normal fine is **\$600.00**, which can be lowered to **\$140.00** with proof of license reinstatement. MVD may extend suspension period for this violation.
- A.R.S.28-701.02A1, A2 OR A3, Criminal Speed. All are Class 3 Misdemeanors. Maximum penalty, \$500 fine, up to 30 days in jail and are 3 point violations. **You must call the court for Bond/Fine amount. (928) 567-6635.**

4. By signing this form I am indicating I wish to give up the above rights, enter a plea of NO CONTEST, and have my bond forfeited in lieu of appearing in court. A NO CONTEST plea will result in a conviction.
5. If you are not a citizen of the United States, pleading guilty or no contest to a crime may affect your immigration status. Admitting guilt may result in deportation even if the charge is later dismissed. Your plea or admission of guilt could result in your deportation or removal, could prevent you from ever being able to get legal status in the United States, or could prevent you from becoming a United States citizen.
